16.01A	PCSO KING: PCSO King was unable to attend the meeting, but had sent a report in which was read out for the period 24/11/2015 – 26/01/2016:

16.01B	PUBLIC PARTICIPATION: Mr Chapman (Handyman) reported that there is still flooding on the Old Yarmouth Road, but this is being dealt with by the PC and Highways. The puddles at the school had also been mentioned to him, but again this has been reported to Highways to look into. It was also reported that the seats on the roundabout and the seats on the toddler swings were wearing. This will be looked into by Cllr Barrett. The cut through at the corner of the playing field onto the road has also been highlighted to the PC and being looked into.
16.01C	COUNTY / DISTRICT COUNCILLOR:
	County Cllr. Timewell: Devolution of Power – certain responsibilities to be handed down to a lower level. The Government want Norfolk and Suffolk to work together, but Cambridge not included. This will happen, but it is a case of how it will happen. There are major committee meetings this week. Locally, there are a lot of road works e.g. Scottow. Also, on Withergate Road the bank at the solar farm has now hopefully been resolved by trees cut down and a lot of drainage put in. Flooding along Station road has been reported to Highways this evening. District Cllr. Williams: The planning meeting regarding the White Lady has been deferred until 11 th February 2016, and hopes to be 1 st on the agenda. This gives time for the planning officer to visit the site to look at the parking that has been put in place, and if the parking has been marked out. Cllr. Williams will put forward the PC's views as per the conditions set out in the letter submitted, regarding traffic management/signs etc If conditions are agreed and not complied with, immediate enforcement would take place. A Licensing hearing also took place for The White Lady, which was considered serious enough to suspend the licence, but have been lenient and granted 4 wedding per year with music and the festival. Again, conditions set to include internal doors to be kept shut. If appealed, this would go to the Magistrates Court. It was argued that the village hall can create noise louder than the pub, but no complaints have been received, therefore this cannot be acted upon. At an event marques can be moved, but this has to also comply with planning conditions.
